Obtaining and access to Personal Data

In some instances, we obtain your data indirectly through other sources of public access or transfer which are permitted by Law.

Personal data that will be processed.

- I.Identification Data: name, address, telephone number, age, signature, Federal Taxpayer Registry, Unique Population Registry ID, Social Security number, telephone number, email, date and place of birth, nationality, age, immigration ID, passport number.
- II. Work and Education Data: positions, experience, work, family or personal references, academic, work and professional career, title, professional license number, languages.
- III.Data on administrative and legal proceedings.
- IV.Sensitive Data: sex, age, weight, religion, psychometric tests, socioeconomic studies, educational level, employee type/grade, criminal record, allergies, health history, current illnesses, chronic illnesses, height, blood type, gender, ethnic origin, religion.

Mechanisms, means, and procedures available to exercise ARCO rights.

- a. Attach (copy of your official identification (INE, passport, or Professional Certificate), or, if applicable, the documents that accredit your legal representation.
- b. A clear and precise description of the personal data for which you seek to exercise any of the ARCO Rights;
- c. Any document or information that facilitates the location of your personal data;
- d. If requesting a rectification of data, you must also indicate the modifications to be made and provide documentation that supports your request; and
- e. Indication of the place where we can review the originals of the attached documentation and indication of the place and reason for which the original documents are made available to us.

BOCAR GROUP may deny your request if you are not the owner of the personal data, your legal representative does not evidence their legal capacity, your personal data is not found in our databases, or the rights of a third party are infringed; there is a legal impediment or the resolution of a competent authority that restricts your ARCO Rights; and when the rectification, cancellation or opposition has been previously made.

Your ARCO Request will be answered by email by the Privacy Officer of BOCAR GROUP within a maximum period of 20 business days from the day your ARCO Request is received. In the event that the ARCO Request is answered affirmatively or is admissible, such changes will be made within a maximum period of 15 business days from the day after the response from the Privacy Officer of BOCAR GROUP is received. The terms referred to in this paragraph may be extended one time for an equal period if necessary.

Protection of your Personal Data.
